#### 1. NOTES ON COMMUNICATION AND DEADLINES

- Communication between the editors and authors will primarily take place via email fnzinfo.geschichte@univie.ac.at.
- The deadline for submitting manuscripts is 30 April.
- For proof-reading, authors will be sent a PDF of the typeset text.
- After publication of the issue, authors will receive between one and three copies (depending on the length of their article) of the issue as well as a digital copy of their contribution in the form of a PDF for offprints. We therefore kindly request you provide us with your postal address to send the physical copies of the issue to.
- Embargo period: We kindly ask all authors to wait for a period of six months before they make their contributions available online (link to website, inclusion in a repository, etc.).
- Please note that due to server restrictions, e-mails sent to us cannot exceed 10 MB.

#### 2. GENERAL INFORMATION ON TEXT AND IMAGES

#### 2.1. Text

- Articles should be approximately 50,000 characters in length (including blank spaces).
   Project reports as well as reports on events or exhibitions should be approximately 15,000 to 30,000 characters; book reviews should not exceed 7,500 characters (including blank spaces), with the exception of omnibus reviews.
- Abstracts in German and English (1,500 characters each, including blank spaces) must be enclosed.
- Manuscripts should not include additional formatting such as hyphenation, justification, tabs, spacing at the beginning of paragraphs, and blank lines between paragraphs. The text should be formatted in Times New Roman 12 with a line spacing of 1.5 and 2.5 cm page margin.
- We accept the following character formats: regular, italics, superscript. We do not use bold text, all-caps or small capitals (except in quotations).

## 2.2. Images, Figures, Charts, Illustrations

- Illustrations are welcome; authors are responsible for securing image rights in advance. Files will be printed in grayscale mode at a resolution of at least 300 dpi. The maximum width is 8.2 cm for one column of text or 17.0 cm for two columns. The maximum height is 23 cm.
- Images, charts, and diagrams must be submitted separately from the text file by email (as TIF or JPEG files), never embedded in a text document.

- Illustrations are to be numbered consecutively in the text. The desired placement of the illustration, including the image file name and caption, must be stated in the manuscript text in a separate paragraph.
- Captions must include the figure number and a description of the figure (location, artist, dating, copyright). Captions must end with a period.

#### 3. TEXT DESIGN

### 3.1. Title hierarchy

• Each article is to be structured like this: title - subtitle - author line - text with subtitles - endnotes.

### 3.2. Spelling

• The editorial team asks for the consistent use of British English (BrE) spelling.

## 3.3. Gender differentiation (not applicable for English texts)

• As German is a gendered language, please consult the German Style Sheet for recommendations on how to use gender-inclusive language.

### 3.4. Italicisation

- Titles of books, essays, events, lectures, paintings, etc. are italicised if they are part of a sentence.
- Words that are to be accentuated and emphasised, as well as foreign-language terms (that have not yet been acknowledged as loan words in the English language) interspersed in the text should also be italicised.

## 3.5. Quotation marks

- Quotations of any kind are placed between single inverted commas ('...'); no distinction is made between sources and research literature. Terms where a certain degree of relativisation or distancing is to be implied are also to be written between single inverted commas.
- Quotations within quotations must be written between double inverted commas ("...").

## 3.6. Formatting of quotations and endnotes

 Please format quotations that exceed three lines as a separate paragraph with single inverted commas. Longer quotations should be formatted as indented paragraphs with one blank line before and after the text.

- Primary sources should be cited as close to the original as possible. Citations of sources taken from secondary literature should be marked with the addition "after ...".
- Additions in quotations are to be put in brackets. Omissions should always be indicated by [...]. Parentheses inside parentheses should be brackets.
- Endnote numbers are always to be inserted directly after a punctuation mark, i.e. without a space. If they refer to a specific word or group within a sentence, endnotes are to be positioned directly after the word or group of words.

#### 3.7. Numbers

- Numbers up to twelve are spelled out as full words.
- For the subdivision of multi-digit numbers, the usual characters are to be used.
  - o Example: 5,000; 10,000; 50,000
- In the text body, the word 'percent' is written out in full, i.e. 'five percent', not '5%' or 'five %'. Reserve the symbol for tables and graphics.
- Superscripts are to be used for English and French numbering (e.g. 2<sup>nd</sup>, XVII<sup>e</sup>), in folio references (e.g. fol. 126<sup>r</sup>–126<sup>v</sup>) and in endnote references.

#### 3.8. Place names

- Abbreviations should be avoided, i.e. always Wiener Neustadt, not Wr. Neustadt etc.
- The common English-language variant should be used for places and cities, e.g. Copenhagen, Warsaw, Moscow, Rome. In the case of places in the Holy Roman Empire and the Habsburg Empire, if names are available in several languages, a decision for either the German or other language variant is to be made by the author and maintained consistently throughout the article. Upon the first mention of the place, the most relevant or most common name variants in other languages are to be added in parentheses.
  - Variant 1: Brünn (Brno), Prag (Praha), Fünfkirchen (Pécs), Breslau (Wrocław), Laibach (Ljubljana), Schemnitz (Baňská Štiavnica, Selmecbánya)
  - Variant 2: Brno (Brünn), Praha (Prag), Pécs (Fünfkirchen), Wrocław (Breslau), Ljubljana (Laibach), Baňská Štiavnica (Schemnitz, Selmecbánya)

#### 3.9. Dashes and hyphens

- The dash (' ') is used when inserting information on a sentence level, but also (without spacing) between page and year numbers and corresponding letter combinations (e.g. 'A-Z').
- The single hyphen (' ') should only be used for hyphenated words and names.

#### 3.10. General abbreviations

- Only common abbreviations (e.g., etc.) should be used in the text.
- If the use of other abbreviations, for example of institutions, is absolutely necessary, the name must be written out in full the first time it is mentioned, and the abbreviation must be added in brackets.
  - Example: Holy Roman Empire (HRE)
- Currency symbols should be avoided in the text: guilder, not fl.; Conventionsmünze, not CM; Wiener Währung, not WW; Kronen, not K.; Kreuzer, not kr.; Heller, not h. Symbols may be used in tables, diagrams and footnotes but should be added when first used or in the legend: fl. (guilder).

#### 4. CITATION RULES

#### 4.1. General rules

- Each endnote begins with a capital letter and ends with a full stop. Multiple references must be separated by a semicolon. The use of 'cf.' should be avoided.
- In the endnotes, the surnames of the authors or editors are emphasised in small caps. Editing institutions of anthologies are not named if editors are mentioned; the editing institutions of journals are generally not named. 'ID.'/'EAD.' in repeated names of authors are written in small caps.
- Multiple authors, editors or places of publication are separated by a slash (without spaces). If there are more than three authors or editors, all are named (no use of 'et seq.'). If there are more than three places of publication (but not more than three authors or editors), only the first one is named and followed by 'et seq.'. The names of the places of publication are written out in full (correct: Frankfurt am Main, incorrect: Frankfurt a. M., Frankfurt/Main).
- Volume references of foreign-language publications are given in English (vol./vols.).
- If different articles from one and the same anthology are used, the complete bibliographical details of the anthology are only given for the first article.
- The names of journals, encyclopaedias, series, etc. are given in full the first time they are mentioned. Subsequently, they may be abbreviated. The abbreviation is to be given in parentheses with the addition 'henceforth:' at the first mention.

- For series titles with subtitles, the subtitles are omitted. Volume numbers of series are
  uniformly indicated with Arabic numerals. New series (n.s.) within series titles are not
  given in brackets, but after a comma.
- In the case of publication locations in other languages, the English of the name is always given (Milan, not Milano).
- Page numbers are preceded by 'p.'. For two consecutive pages, the indication of 'f.'
  (e.g. 'p. 38f.' for pages 38 and 39) is permitted. 'f.' for the indication of the following
  page is given without a spatium. The indication 'ff.' for an undefined number of

subsequent pages is not permitted. Columns must be preceded by 'col.'. In the case of folio references, the front and back pages are indicated by a superscript 'r' or 'v' (e.g. 'fol. 3"). If a specific section is to be indicated in the first citation of articles in journals, anthologies and encyclopaedias, the page numbers of the article are to be supplemented with the indication "see p./col. x" (see for an example chap. 4.4.). If several page numbers are given for a title, they are separated by a comma; the semicolon is reserved for separating two different titles.

- In the case of citations in foreign languages (exceptions: German and French), a translation of the title and subtitle should be added in brackets.

- In the case of historical prints (year of publication before 1800), the publisher or printer should be cited, if available. Long titles can be abbreviated with "[...]". Reconstructed names of authors are to be placed in square brackets.

  in abbreviated form in the following. The abbreviation should be given in parentheses
  with the addition 'henceforth:'. The usual abbreviations are to be used.
